1. Apologies for Absence

Apologies were received and accepted from Cllrs Evans, Ewing and Munson and District Councillor Thompson.

2. Declarations of Interest

There were no declarations of interest disclosed.

3. County and District Councillors

The following was reported on behalf of Cllr Durham:

"Clearly since the new government came to power in July, a lot of things have, or will change in due course. We are still in uncharted waters regarding the new NPPF and the extremely worrying potential housing figures for Maldon District and we know that devolution is likely before the end of this parliament. We will not know about wider issues until after the autumn budget when the new chancellor will unveil her spending review. It is too soon to draw any conclusions about where local government will be or many other issues that will definitely impact everyone in the land.

I think it will be helpful if I provide a full update on the current state of affairs after the budget when we will know more about the future. In the meantime we have allocated a further £25m to the highways budget for priority works. This will include resurfacing and repairs to many rural roads as well as major routes. We will shortly have a total of 12 new machines for patching work that are being rolled out at the moment. You may well be seeing the results of this already.

I still have some Locality funding available which has to be allocated by the end of this year, so if there is a project in your area, please let me know. I am also about to submit the next round of member led highway repairs and we have already addressed some issues in Tollesbury and Tolleshunt Knights. Please let me have a list of the most important issues locally and I will add them to the lists."

Action: Cllr Denney will provide the Clerk with a list of highway issues, including the broken school sign on Tollesbury Road, potholes in Beckingham Road and the drains in Chapel Road. Once received, the Clerk will forward the list to Cllr Durham.

4. Public Forum

There were no members of the public present.

5. Parish Working Group (PWG)

Steve reported:

Overgrown Hedge Festival Gardens/Beckingham Road

The hedge has been trimmed back.

Cllr Henderson advised that the brambles had not been cut back and were overgrown onto the footpath.

The Clerk advised that the resident had been written to and they had advised that they were arranging for a contractor to cut the hedge back.

Action: To be monitored.

Bollards and CCTV installed outside Rubys – Is this allowed?

The Clerk advised that a resident had also raised this with her. With regards to the CCTV, the resident has been advised to report this to Essex Police directly. The Chairman advised that as this is on private property, it is not a Parish Council matter. However, as it is in the conservation area, permission may have been needed before installing the bollards.

Action: Clerk to ask the Conservation Officer at Maldon District Council to see if permission would be required to install the bollards.

- Village Shop The Conservation Officer has written to the shop owner.
- Land Adjacent to 13 Church Street The appeal has been dismissed.
- Area outside the school The works have now been completed by Bonz.

Resolved: Unanimously agreed to object to this application as Councillors oppose the felling of the sycamore tree.

7.2 Application No: 24/00697/WTPO PP-13382154

Proposal: (A1 on TPO 2/90) T1 Oak - Crown reduction by 4m. Crown lift to 4m.

Location: 23 D'Arcy Way Tolleshunt D'Arcy

Resolved: Unanimously agreed to recommend approval of this application.

7.3 Application No: 24/00524/TCA PP-13206679

Proposal: T1 - Oak - Crown reduce by 30%, removing up to 4m growth. H12 - Lawson Cypress Hedge - Remove 1 of 4 stems nearest the house. T8 - Holly - Continue to keep current size 0.5m below overhead telephone lines, by removing no more than 0.5m growth.

Location: The Grey House Chapel Road Tolleshunt D'Arcy

Resolved: Unanimously agreed to recommend approval of this application.

The cost of the path will be covered by Blackwater Gymnastics and they will appoint a Contractor who will fully comply with Parish Council's specifications.

Cllr Middleton reported that he was in the process of obtaining quotations for the repairs to the gym/play equipment.

14. Grant Application

Resolved: Unanimously agreed to give a grant of £29.98 towards a replacement Dictaphone for Community Speed Watch.
